

TOWN OF ULSTER PUBLIC LIBRARY  
BOARD MEETING  
NOVEMBER 22, 2011

The Meeting was called to order at 6:05 by President Ruth Quick.

In attendance were: Richard Metzger, Ann Davis, Jeanette DeBeaumont, Rotena Nippert, Mary Nielsen, Cynthia Wadnola, Faith Johnson, and Library Director. Jackie LaBarge was late. Walter Maxwell was excused.

MINUTES:

A motion was made to add Mary Nielsen's name to the list of attendees of the previous meeting. Rotena Nippert questioned the cost of the UPS ES500. A motion was made by Tena Nippert to accept the cost and seconded by Ruth Quick. A motion to approve the minutes from October 25, 2011 with amendments was made by Ann and seconded by Cynthia. All in favor.

DIRECTOR'S REPORT:

- End of year payment adjustment: Janice, Faith & Brenda should receive 1 week salary each. There are 5 part-timers. Each should receive \$100. Hailey to receive \$25. To be paid with December payroll. Motion made to accept by Jeanette – seconded by Ann. Vote was taken. All in favor - 0 opposed.

A list was given to Richard Metzger to check for repair. It was decided that Richard would do the inside repairs and Jim Sass would take care of the outside repairs.
